MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on 21 August 2012.

BETWEEN

The **UNIVERSITY OF THE SUNSHINE COAST** (ABN 28441859157), a body corporate established pursuant to the *University of the Sunshine Coast Act 1998* having its campus at 90 Sippy Downs Drive, Sippy Downs, 4556 in the State of Queensland Australia.

("USC")

AND

The **INSTITUTE OF PHYSICAL EDUCATION**, an institution administered by the Government of Thailand having its office at 333 Sukhumvit Road., Muang District, ChonBuri 20000 Thailand.

("IPE")

RECITALS

- A. USC is based in the State of Queensland, Australia. USC is a comprehensive public university committed to international education and co-operation.
- B. IPE is located at ChonBuri Province, is a public institution in Thailand.
- C. This Memorandum of Understanding provides for the establishment of a general framework to co-operate in the areas of student recruitment, staff and student exchange, credit recognition, pathway programs and other general collaboration between USC and IPE.

Now it is understood by the parties as follows:

1. Responsibilities of USC

Provide IPE with necessary information and other documentation pertaining to USC's programs.

Visit IPE and host IPE visiting delegations to discuss the terms and conditions that would form longer term, specific Agreements between the two parties.

2. Responsibilities of the IPE

Provide USC with the necessary information and other documentation pertaining to IPE's programs.

Visit USC and host USC visiting delegations to discuss the terms and conditions that would form longer term, specific Agreements between the two parties.

3. Financial Arrangements

The two parties agree that they have separate financing responsibilities for this preliminary stage of cooperation and discussion. Neither party may call upon the other party for advance funding to meet advance expenditure obligations.

4. Intellectual Property

The recipient, its employees, staff, researchers and students, shall treat all information and material supplied by USC and IPE in accordance with or pursuant to the Memorandum of Understanding as confidential.

5. Disclosure of Information

The two parties, their employees, contractors or agents shall not disclose or make public any information or material acquired or produced in connection with or by the performance of this Memorandum of Understanding without the prior written consent of the other party.

6. Variation

This Memorandum of Understanding may be extended with the agreement of the parties. The terms and conditions for any such extension shall be agreed in writing and signed by the two parties.

7. Termination

This Memorandum of Understanding shall cease at any time provided one of the parties gives written notice to the other of its intention to terminate the discussions referred to above. In the event of termination under this Clause, neither party can claim from the other in respect of expenditure or obligations incurred up to the date of termination.


